Upon receipt of application, the Silver Legacy will have two (2) days to notify said applicant whether or not they've been accepted to tailgate at The Biggest Little Tailgate Party.

CONDITIONS FOR TAILGATE SPACE:

- A. The Silver Legacy will not consider your application unless your **\$50 application fee and a picture of your tailgate set up is included with this form**. Checks must be made payable to the **Silver Legacy Resort Casino**. Return application and check to the Silver Legacy, **Attn: Special Events/ Will Saring**, P.O. Box 3920 Reno, NV 89505. Application consideration will be made on a first come, first qualified and first placed basis. Limited space is available and a sellout is anticipated.
- B. **Full payment of Tailgate application fee must be received by the Silver Legacy Resort Casino no later than January 21, 2009.**
- C. We reserve the right to place all applicants on the site according to our master plan. If using a tent, no closed sides may be facing the Virginia St. businesses. Applicants are NOT permitted to relocate their vehicles outside their assigned areas. Applicants are responsible for clean up of their site at the event's closing.
- D. Per the Washoe County Health Department, all food and beverage served at the individual tailgate parties must be served only to the invited guests of the applicant. Any applicant that provides food and beverage to the public, in any manner, will be subject to the fees, rules and regulations of the Washoe County Health Department. All service ware for the tailgate parties must be plastic or aluminum. **NO GLASS ALLOWED ON VIRGINIA STREET**. No emptying of grease into storm drains or cleaning of BBQ's on site. Trash receptacles and recycling containers will be located throughout Virginia Street.
- E. Tailgate parties are required to remain open during the time of the event, 10 am to 4 pm on Saturday, January 31, 2009. Hours subject to change. If changes occur, you will be notified in advance.
- F. Applicants **WILL NOT** be furnished with any tailgate booth accommodations (tables, chairs, canopies, etc.) All preparation and storage must be within provided tailgate area. If you have a tent or canopy, it must be secured by water barrels or concrete ballast. If the City of Reno determines that your tent or canopy set up poses a danger to the public, you may be asked to remove it.
- G. Per the City of Reno Fire Department if you are cooking, all cooking must be done on a propane device. No charcoal or any other flammable material may be used. Each tailgate party must have their own portable fire extinguisher on site. Contact the City of Reno Fire Department at (775) 333-7772 for more details.
- H. All vehicles used for the event, must be moved into their space beginning at 7 am and completed by 9 am the day of the event and moved out of their tailgate space by 5 pm on January 31, 2009. Each vehicle must display their credentials in the front passenger window. Entry to the event is at 5th and Virginia Streets. Vehicles that do not have an unimpaired driver will be driven out of the tailgate area by a Valet attendant and parked in one of the sponsoring casino garages or the Circus Circus parking lot, located at 6th and Sierra. Keys for these vehicles will be kept at the respective Valet department until the applicant retrieves them, unimpaired.

- I. Cancellation policy will include a \$25 NON-REFUNDABLE processing fee. Refunds will be granted only if written notice of cancellation is received by January 21, 2008. If an applicant is admitted to the party after January 29, 2009, all fees will be non-refundable. **Event produced rain or shine.**
- J. **Indemnification:** Participant agrees to indemnify Biggest Little Tailgate Party, Silver Legacy Resort Casino, Sponsors, City of Reno, State of Nevada, Washoe County, and their officers, directors, trustees, employees, agents, representatives, volunteers and servants, and anyone else connected with the management or presentation of the Biggest Little Tailgate Party and will hold and save each of them harmless from any and all actions, claims, damages to persons or property, penalties, obligations, liabilities or attorney's fees that may be asserted or claimed by any person, firm, entity, corporation, political subdivision or other organization arising out of any negligent or intentional tortuous acts, errors, or omission of vendor, its agent, employees, subcontractors, or invitee, provided herein and arising out of the performance of this agreement.
- K. Returned checks- a service charge of \$25 will be assessed for any check returned for non-payment.
- L. Biggest Little Tailgate Party logo may not be used without written permission of the Silver Legacy Resort Casino.
- M. If space is assigned, and the Silver Legacy accepts this application, agree to abide by the rules and regulations stipulated in the License Agreement. The Silver Legacy reserves the right to refuse any application that does not meet the event's requirements, and may refuse to execute an agreement without giving reason for same.
- N. All tailgate applicants are subject to City of Reno noise regulations in terms of any car stereos or other amplified sound equipment brought to the event.
- O. Each applicant will receive one raffle ticket, good for the \$1 Million Dollar Football Throw drawing on Saturday, January 31, 2009 at 12 noon.
